## \*\*Re-Judging Policy

From prior experience, we know that a majority of projects are judged fairly, reflecting the degree to which a student has met established judging criteria. We do, however, recognize that occasionally a project may be judged too severely, or an oversight may occur. A mechanism does exist to invoke re-judgment in such cases. The following rules regarding re-judging will be utilized:

"Two judges will judge each project for the Ohio Academy of Science ratings. If each judge grants a total score within any one rating category (Superior, Excellent, Good, or Satisfactory), that specific rating will be granted to the student and no re-judging is permitted. Re-judging is automatic and is permissible **ONLY IF <u>ALL THREE</u> OF THE FOLLOWING CONDITIONS APPLY**:

1. The judges' final ratings are in different categories;

- 2. The average of the judges' scores is in the lower category, and;
- 3. If the judges differ in their total points by more than five points."

\*\*\*Certificates and award ribbons will be placed at the projects while the students are at lunch. Therefore, students are encouraged to leave their projects displayed and not remove them until near the end of public viewing, after 2:00 p.m.
